Thackersey, his wife in April 2023 and as such there is the difference in holding of Leena C. Thackerseydue (increase from 0.39% to 7.76%). Discrepancy no.3 No. of promoters in March 2023 quarter were 12; Asmentioned earlier,shares of late Mr. Chandrahas K. Thackersey were transmitted in April 2023 to the existing promoter and shareholder Mrs. Leena C. Thackersey; hence, no. of promoters have reduced from 12 to 11.
